### 3 Applicant's Statement

The Applicant represents that they have familiarized themselves with, and understands well, the terms and conditions laid down in the Invitation to Tender and the Annexes thereto and that, if frequencies are allocated to them, the Applicant will accept the terms and conditions, rights and obligations, commitments and any other limitations with respect to the frequencies specified in the Invitation to Tender.

In addition, the Applicant represents that they submit this Application being aware of the terms and conditions and obligations referred to in Annex 1 to the Application and that they have familiarized themselves with the wording of the Annex 1 to the Application and the obligations specified therein and that they accept them.

The Applicant consents to the deposition of a financial Security in accordance with the Invitation to Tender. The Applicant acknowledges that in the event of becoming the Auction Winner and in the event that the Total price exceeds the Security provided by the Applicant, CTU will credit the Security provided by the Applicant against the Total price. CTU will invite the Applicant to pay the difference between the Total price and the Security. In the event that the value of the Security is higher than the Total price CTU will return the positive difference between the Security and the Total price to the Applicant in accordance with chapter 9.3 of the Invitation to Tender.

In addition, the Applicant represents that all the information provided in this Application for the granting of rights to use radio frequencies is true and that the submitted copies of documents conform to the original documents. The Applicant is aware that deliberate provision of false information or provision of incomplete information may result in criminal law penalty in accordance with the Criminal Code<sup>4</sup> and the act on criminal liability of legal entities<sup>5</sup>.

The Applicant acknowledges that the Czech Telecommunication Office may, in accordance with the terms and conditions laid down in the Invitation to Tender, ask the Applicant to clarify, correct or amend in writing the information or documents submitted as evidence of the fulfilment of the above-mentioned requirements for the Application.
