CORRIGENDUM OF OBVIOUS INACCURACIES in the text of the Invitation to tender for the award of the rights to use radio frequencies for providing a public communications network in the 800 MHz, 1800 MHz and 2600 MHz bands

The Czech Telecommunication Office (hereinafter the „Office“) was notified, in relation to the publication of the text of the Invitation to Tender for the award of the rights to use radio frequencies for providing a public communications network in the 800 MHz, 1800 MHz and 2600 MHz bands (hereinafter the “ITT”), that there are obvious inaccuracies in the text of the ITT. For avoidance of doubt, the Office publishes the following corrigendum.

The conditions of the tender for the award of the rights to use radio frequencies for providing a public communications network in the 800 MHz, 1800 MHz and 2600 MHz bands are not changed by this corrigendum of obvious inaccuracies.

The corrigendum concerns the following points:

1. A correction of the text of the ITT, chapter 5.1.1, second bullet on page 23, where the stated value of limit EIRP is not in accordance with the results of the public consultation

1.1. The original wording of the text of the ITT, Chapter 5.1.1, second bullet on page 23:

„limit value of the EIRP (Equivalent Isotropically Radiated Power) for the base stations inside the block = 60 dBm/(5 MHz) with the understanding that in the areas of interference the EIRP value will be adequately reduced in keeping with the results of the test operation; “

1.2. The correct wording of the text of the ITT, Chapter 5.1.1, second bullet on page 23:

„limit value of the EIRP (Equivalent Isotropically Radiated Power) for the base stations inside the block = 62 dBm/(5 MHz) with the understanding that in the areas of interference the EIRP value will be adequately reduced in keeping with the results of the test operation; “

2. A correction of the text of the ITT, chapter 5.1.5, point 3, where a requirement to provide own results of data speed measurement is stated in contrary to the results of the public consultation

2.1. The original wording of the text of the ITT, Chapter 5.1.5, point 3:

„The results of the data flow speed measurements according to the methodology mentioned in the Appendix 3 to the ITT proving the fulfilment of the minimum required speed of the service according to Chapter 5.3 of the ITT. “

2.2. The correct wording of the text of the ITT, Chapter 5.1.5, point 3:

The entire point 3 of Chapter 5.1.5 of the ITT is deleted.

3. A correction of the text of the ITT, Appendix 3, chapter 5, point e), where an incorrect reference to points 5 d) and e) is stated

3.1. The original wording of the text of the ITT, Appendix 3, chapter 5, point e):

„In the event that the measured coverage according to the points 5 (d) to (e) will be diametrically different from the predicted measurement, a negotiation must be held between the Office and the network operator to agree on how to proceed further to identify the causes of the differences. “

3.2. The correct wording of the text of the ITT, Appendix 3, chapter 5, point e):

„ In the event that the measured coverage according to the points 5 (b) to (d) will be diametrically different from the predicted measurement, a negotiation must be held between the Office and the network operator to agree on how to proceed further to identify the causes of the differences. “

4. A correction of the text of the ITT, Appendix 4, chapter 4.5, where the last bullet in the list of information provided to Auction Participants after the evaluation of each Auction Round in a report is incorrectly stated

4.1. The original wording of the text of the ITT, Appendix 4, chapter 4.5:

The last bullet of chapter 4.5 on page 15 of the Appendix 4 to the ITT: „in the case of a reduction of the price of an Auction Lot in accordance with Chapter 4.4.6 of the Auction Rules: information about the new Auction Lot price for the next Auction Round, for which the price was reduced, and information about the increase in the Auction Participant's Eligibility own points if such an increase occurred in this connection. “

4.2. The correct wording of the text of the ITT, Appendix 4, chapter 4.5:

The last bullet of chapter 4.5 on page 15 of the Appendix 4 of the ITT is deleted. New paragraph is added to the end of the chapter 4.5: „ In the case of a reduction of the price of an Auction Lot in accordance with Chapter 4.4.6 of the Auction Rules, an information about the new Auction Lot price for the next Auction Round, for which the price was reduced, and information about the increase in the Auction Participant's Eligibility own points, if such an increase occurred in this connection, will be send to the Auction Participants via the EAS.“
